PHILOSOPHIES ABOUT APhA-ASP

My main philosophy I would love to bring forth to APhA-ASP on a national level is the concept of "find your why". Coming out of the pandemic, it was a challenge to get the chapter excited for initiatives and patient care. We combatted this by instating what we called, "Operation Roles and Chapter **Contributions**". This was a document for each of the Patient Care Projects consisting of questions such as: "how does the operation provide opportunities for professional development, connection, and leadership for Student Pharmacists?" and "how will the operation advance Pharmacists' role in patientcentered care?". Our goal with this document was to inspire our chairs to come to understand why they do what they do. Having a well-thought-out answer to this question puts the student at an advantage to answer potential questions about operation initiatives in an interview setting. We spend so much time as student pharmacists working hard and volunteering in these organizations. It is important to understand our motivations and why they advance our profession and help us grow as people as well.

The patient care projects are the main outlet for member engagement; my chapter is lucky enough to have passionate chairs that love to showcase what pharmacists are capable of. As chapter president, I get to work with each of our eight operations. I am always excited to help them plan events and community outreach. A great example of this happened during the COVID-19 vaccine push in 2021: our operation immunization had a hand in immunizing over 25,000 community members. It also increased our patients' trust in our skills and made us a liaison for information about the pandemic and the vaccine itself.
