BACKGROUND & EXPERIENCE

My involvement in pharmacy organizations started during my pre-pharmacy years when my school's APhA-ASP chapter president began to mentor me and expose me to the endless opportunities found in organizations like APhA. Immediately after starting pharmacy school, I was elected to the position of president-elect for our APhA-ASP chapter and am currently serving my term as the chapter president. The experience I have gained through this position is beyond measure. Attending APhA-ASP's Summer Leadership Institute (SLI) alongside chapter leaders from across the country this past July greatly amplified my exposure to and passion for the Academy of Student Pharmacists and all the incredible strides they are making for the profession.

I genuinely believe that championing for the future of pharmacy requires actively investing in those who will be the future of the field. When I was a pre-pharmacy APhA member, I was heavily impacted by the organization, and I longed to see others reap the benefits of involvement during their pre-pharmacy years as well. When the Pre-Pharmacy Organization was established, I served as the Founding President, and my involvement has continued into pharmacy school through Pharmacy Friends Mentor and Student Pharmacist Liaison positions. Upon stepping into my role as APhA-ASP chapter president, I worked with the admissions office at the College of Pharmacy to coordinate incentives for pre-pharmacy students to join APhA for the entire duration of their pre-pharmacy education. In addition, I have implemented a new Pre-Pharmacy Liaison position on our executive council to ensure that every facet of our membership is represented and leveraged for the profession. After implementation of this organization, the pre-pharmacy program has seen elevated retention rates and engagement, and our local APhA-ASP chapter has seen significantly increased membership among those preparing for matriculation into pharmacy school.

In an effort to be involved in policy and advocacy on a state level, I have been an active participant in the Tennessee Pharmacists Association, serving as a Tennessee Society of Student Pharmacists Member-at-Large for two consecutive years and as a delegate within the House of Delegates. During my time in this capacity, I have become well acquainted with the processes involved with policy. As I have learned the art and skills of advocacy within the political terrain, I have created workshops that train and equip members of our chapter to understand the legislative agendas the association is endorsing, engage with government representatives, and confidently share the ways that pharmacy is impacting their voters' personal lives.
