Background

- Launched in 2001
 - Over 700,000 individuals have been screened since then
- In 2021-2022 alone:
 - 122 chapters participated
 - 8,679 student pharmacists participated
 - 401 faculty and staff members participated
 - 315 pharmacy practitioners participated
 - 680 Operation Diabetes events conducted
 - 14,618 patients screened
 - 1,715 patients referred to their primary care provider
 - 12,667 patients received health and wellness services
 - 2,637,327 individuals reached through public relations initiatives

Educate individuals in the community who are at risk of developing diabetes


Increase student pharmacist awareness of the needs for early detection and prevention of diabetes
